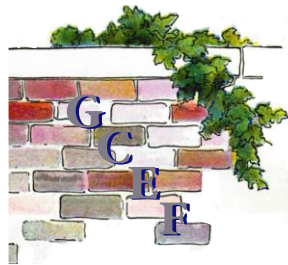

# RULES AND GUIDELINES FOR SCHOLARSHIP APPLICATIONS

## GRAPE CREEK Education Foundation

Hello Graduating Senior,

Thank you for applying for a scholarship through Grape Creek Education Foundation (GCEF). The following guidelines are provided to make application easier for you and for the Foundation Selection Committee. Please read carefully and follow the guidelines itemized below.

**ELIGIBILITY AND QUALIFICATIONS:** The scholarship applicant must:

1. **Meet ISD Enrollment:** The applicant must be a **Grape Creek Independent School District senior** who is scheduled to graduate in the spring of the current school year.
2. **The applicant must not be selected for a FULL scholarship from another source**
3. **Comply with Application Deadline:** **All** requested information must be received by GCEF **no later than 3:00 p.m. on the last Monday in January.**
4. **Submit all Requested Information:** Required materials include completed Scholarship Application, Official Transcript to Date and completed Reference Forms.
  - a. **Application Form** is completed and submitted by the student.
  - b. **Reference Forms** are to be *submitted directly to GCEF by each person completing the form.* **Two (2)** forms must be completed by two (2) of the student's GCISD teachers **AND one (1)** form must be completed by the student's counselor, administrator or a non-related outside source (i.e. clergy, employer, youth minister, Boy Scout troop leader etc.).
  - c. **Official Transcripts (to date) are the responsibility of the applicant. A Transcript Request Form is provided in this package. Give this form to your school counselor as soon as possible. Your counselor will return the official transcript to GCEF. Applications received without an official transcript will be immediately disqualified.**

**Format Instructions:**

1. **Use this form and this form only** for your responses. Please do not create your own form.
2. Use only **8 ½" X 11" paper** for response to Parts II and III. **PLEASE DO NOT RESPOND ON NOTEBOOK PAPER.**
3. Since applications will be copied for review, **typed responses are preferred.** If completing by hand, please print legibly, using **black ink.**
4. Please **SECURE PAGES WITH A PAPERCLIP**, rather than with a staple. Do not place in a binder.

**GUIDELINES TO APPLICATION SECTIONS**

1. **Information Page:** Use only the form provided, completing **ALL** information requested. Enter N/A when information is not applicable.
2. **Part I: PARTICIPATION AND LEADERSHIP:** Use only the space provided, and do not attach a resume. Section B, Community Activities/Organizations/Awards, indicates volunteer service and organizations within your community, such as Scouts, 4-H or other.
3. **Part II: EDUCATION:** Answer questions on a separate 8 ½" X 11" sheet of paper. **Limit responses to one page, front side only.** Title the page as **PART II: EDUCATIONAL INFLUENCES.** Label each response as A, B, or C.
4. **Part III: GOALS:** Answer questions on a separate 8 ½" X 11" sheet of paper. **Limit response to one page, front side only.** Title the page as **PART III: GOALS.** Label responses as A or B.
5. **Part IV: REFERENCES:** Enter your name and your school **before** distributing the reference forms. **Contact references as soon as possible to provide ample response time prior to submission deadline. MAKE SURE YOUR REFERENCES ARE AWARE THAT THE REFERENCE MUST BE RETURNED BEFORE 3:00 pm ON THE LAST MONDAY IN JANUARY. All references are confidential and must be returned by the responder directly to GCEF before 3:00 p.m. on the last Monday in January.** Provide your references with stamped envelopes, addressed to **GCEF** as listed below.

**SUBMITTING THE APPLICATION**

1. Use the **Applicant Submission Checklist** to assure completion of all required information. Please do not return the Checklist.
2. Applications and all information submitted with the application become the property of the Grape Creek Education Foundation.
3. Comply with **Submission Deadline:** Applications, references and official transcripts **MUST** be received by GCEF **before 3:00 p.m. on the last Monday in January.** Applications can be mailed or hand delivered as follows:

- \_\_\_\_\_ 4. References have been requested, a stamped addressed envelope was given and reference was notified of deadline to assure return within specified timeline.
- \_\_\_\_\_ 5. Where appropriate, an essay may be included for consideration as recipient of related scholarships.
- \_\_\_\_\_ 6. Application Affidavit is signed and submitted with application.

REMEMBER – THE COMPLETED APPLICATION, ALL THREE REFERENCES AND YOUR OFFICIAL TRANSCRIPT MUST BE RECEIVED BY THE GRAPE CREEK EDUCATION FOUNDATION **BEFORE 3:00 PM ON THE LAST MONDAY IN JANUARY.**
